# Diabetes Mellitus Coding Tips



#### **HEDIS®**

#### Exclude members who:

- 1. Did not have a diagnosis of diabetes in any setting, during the measurement year or the year prior to the measurement year, **and** who had a diagnosis of polycystic ovarian syndrome, gestational diabetes, or steroid-induced diabetes, in any setting during the measurement year or the year prior to the measurement year.
- 2. Members in hospice or using hospice services any time during the measurement year.
- 3. Members who died any time during the measurement year.
- 4. Members receiving palliative care any time during the measurement year.

#### Hemoglobin A1c Control for Patients With Diabetes (HBD)

**Controlled** — **<8.0%**: Submit CPT<sup>®</sup> II code lab values **Poor Control** — **>9.0%**: Submit CPT II code lab values

Members ages 18–75 with diabetes (type 1 and type 2) who were compliant with HbA1C control (<8.0) or non-compliant (>9)

# Statin Therapy for Patients With Diabetes (SPD)

### **Recieved Statin Therapy**

Dispensed at least one statin medication of any intensity

#### **Statin Adherence 80%**

Remained on statin medication of any intensity for at least 80% of the treatment period.

Members ages 40–75 with diabetes who do not have clinical atherosclerotic cardiovascular disease (ASCVD)

# Blood Pressure Control for Patients With Diabetes (BPD)

Controlled — <140/90: Submit CPT II code values

#### **CPT II:**

Diastolic Systolic

3078F = <80 mm Hg 3074F = <130 mm Hg 3079F = 80-89 mm Hg 3075F = 130-139 mm Hg

Members ages 18–75 with diabetes (type 1 and type 2) who had BP control (<140/90 mm Hg)
